

Visit MY.NMSU.EDU



CLICK ON FINANCIAL AID STATUS


First Time Users will have to register their account.

CLICK ON FINANCIAL AID STATUS


To view your financial aid progress, award, or verification requirements, click on the "Financial Aid Status".


SELECT AID YEAR

ACADEMIC PROGRESS STATUS


On this page, you will be able to see your Academic Progress Status. If you click on "academic progress", you will also be able to see your status for previous semesters.



VIEWING YOUR FINANCIAL AID AWARDS


CLICK ON AWARD

After you have signed in and accessed the Financial Aid tab, click on "Award" to view your Financial Aid award for a specific aid year.




SELECT AID YEAR

CLICK ON THE "AWARD OVERVIEW" TAB


Select the "Award Overview" tab to view your Cost of Attendance, Estimated Family Contribution, and your award amounts for the academic year.

After you have reached the "Award Overview" tab (as instructed in the above slides), you will be able to view and accept the Terms and Conditions. *You will have to accept the Terms and Conditions before you can accept your award offers. Navigate to the "Terms and Conditions" tab. Click the link to read the Terms and Conditions, and then click "Accept".





CLICK ON THE "ACCEPT AWARD OFFER" TAB

After you have accepted the Terms and Conditions, you will be able to accept your award. Navigate to the "Accept Award Offer" tab. You will see your awards for the Fall and Spring semesters, and be able to accept the full amount of all awards, or accept awards individually.




Select your decision to accept or decline the award from the drop down menu. If you want to accept a partial loan, enter the amount you'd like to accept.

ACCESSING VERIFICATION REOUIREMENTS


CLICK ON THE "STUDENT REQUIREMENTS"



CHECKING YOUR STUDENT ACCOUNT BALANCE


Student Account
